Mary's Little Remnant is a Catholic lay order and is not associated with the so-called Catholic Church in Rome, which is not the true Catholic Church. According to the true Catholic faith, Catholics are banned from taking the USA Pledge of Allegiance and joining the USA military because they would have to consent to heresies and immoralities.

The USA Pledge of Allegiance

USA Pledge of Allegiance: “I pledge allegiance to the flag of the United States of America, and to the republic for which it stands, one nation under God,¹ indivisible, with liberty and justice for all.”

It is heretical because the USA is not under the true God, the Catholic God. Instead, the god of the USA is Satan.

It is heretical because God, as well as any sane society, does not promise liberty to all men. God “hath commanded no man to do wickedly, and he hath given no man license to sin.” (Eccus. 15:21) Even the USA implicitly acknowledges this when they put criminals in jail and deprive them of liberty. God does not give liberty to men guilty of original sin or mortal sin. God gives true liberty only to Catholics in a state of grace. Hence the following applies to the USA and all other republics and democracies:

“Leaving the right way they have gone astray... These are fountains without water, and clouds tossed with whirlwinds, to whom the mist of darkness is reserved. For, speaking proud words of vanity, they allure by the desires of fleshly riotousness, those who for a little while escape, such as converse in error: Promising them liberty, whereas they themselves are the slaves of corruption. For by whom a man is overcome, of the same also he is the slave.”
(2 Pt. 2:15-19)

The USA Constitution

The First Amendment is good for Catholics

The First Amendment of the USA Constitution is a lesser evil law that Catholics can hence support because it allows them religious liberty, even though it allows the same for false religions, which is heretical:

LESSER EVIL LAW: The First Amendment: “(Freedom of expression and religion)
Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press...”

Religious liberty for Catholics in non-Catholic States is a good thing. However, religious liberty for non-Catholics in Catholic States is a sinful and heretical thing. That does not mean non-Catholics are not allowed to believe in and practice their false religions in Catholic States but only that they must do so privately and thus not publicly.

The Fifth and Eighth Amendments are heretical

However, the Fifth and Eighth Amendments of the USA Constitution are heretical in all cases:

NULL AND VOID - The Fifth Amendment: “No person...shall be compelled in any criminal case to be a witness against himself...”

This is heretical because it condones lies and sins of omission by allowing by right of law a guilty man to lie or remain silent about his guilt. “The just is first accuser of himself.” (Prv. 18:17) “Confess therefore your sins one to another.” (Jam. 5:16)

NULL AND VOID: The Eight Amendment: “Cruel and unusual punishments [shall not be] inflicted.”

This is heretical because God condones many kinds of torture under certain circumstances. “Judgments are prepared for scorners and striking hammers for the bodies of fools.” (Prv. 19:29) “Torture and fetters are for a malicious slave.” (Eccus. 33:28) See (2 Ki. 12:31). After all, God tortures devils and humans in hell forever: “And the smoke of their torments shall ascend up for ever and ever, neither have they rest day nor night.” (Apoc. 14:11) “They shall have their portion in the pool burning with fire and brimstone...” (Apoc. 21:8)

The Thirteenth Amendment is heretical because it condemns slavery for non-convicted criminals

NULL AND VOID: The Thirteenth Amendment: “(Slavery and Involuntary Servitude) Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction.”

This is heretical because God condones slavery, not just for convicted criminals but also for whole groups of people either because of their sins or the sins of their forefathers. St. Peter says, “Slaves be subject to your masters with all fear, not only to the good and gentle but also to the froward. (1 Pt. 2:18) St. Paul says, “Slaves be obedient to them that are your lords according to the flesh, with fear and trembling.” (Eph. 6:5) And “Whosoever are slaves under the yoke, let them count their masters worthy of all honour.” (1 Tim. 6:1) After all, during the Old Covenant era God ordained that his chosen people, the Jews, could own slaves and would become slaves themselves if they grievously disobeyed him, as happened when God made them slaves in Egypt and Babylon.

The Nineteenth Amendment is heretical because it allows women to vote

NULL AND VOID: The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of sex. Congress shall have power to enforce this article by appropriate legislation.

This is heretical because women, as a general rule, must be submissive to men. This law, then, overturns that natural order of the relationship between men and women. And in the long run overturns that natural order of the family by placing wives equal to or above their husbands and by placing women, as a general rule, equal to or over men in positions of authority.

“To the woman he [God] said, ...thy submission shall be to thy husband, and he shall rule over thee.” (Gen. 3:16) St. Paul says, “Let women be subject to their husbands, as to the Lord.” (Eph. 5:22) And St. Peter says, “Let wives be subject to their husbands.” (1 Pt. 3:1) “A woman, if she have superiority, is contrary to her husband.” (Eccus. 25:30)

However, Catholic women can vote in non-Catholic nations that allow them to vote in order to overturn evil laws and work toward abolishing the right for women to vote. But they must vote in accord with the dictates of the Catholic Church.

USA Military

USA Military Oaths

Oath of Enlistment: “I, _____, do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; and that I will obey the orders of the President of the United States and the orders of the officers appointed over me, according to regulations and the Uniform Code of Military Justice. So help me God.”²

Oath for Commissioned Officers: “I, _____, having been appointed an officer in the Army of the United States, as indicated above in the grade of _____, do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies, foreign and domestic, that I will bear true faith and allegiance to the same; that I take this obligation freely, without any mental reservation or purpose of evasion; and that I will well and faithfully discharge the duties of the office upon which I am about to enter; So help me God.”³

These oaths are heretical because Catholics are banned under pain of heresy from giving their faith and allegiance to the heretical laws in Constitution of the United States that are not lesser evil.

The words “I will support and defend the Constitution of the United States against *all* enemies, foreign and domestic” is heretical and traitorous because Catholics are forbidden under pain of heresy and treachery to defend the non-Catholic USA above *all* else. In cases in which the pope, a local Catholic bishop, or other competent Catholic authority commands Catholics not to fight in an army or war, Catholics must obey the Catholic Church and not the non-Catholic State and army and thus not fight in that army or war.

Pledges or Oaths that Catholics could take

The apostate antipopes are the guiltiest for allowing so-called Catholics to take the heretical Pledge of Allegiance and Military Oath and thus make it impossible for them to be Catholic. “They are blind, and leaders of the blind. And if the blind lead the blind, both fall into the pit.” (Mt. 15:14) They should have fought for another pledge of allegiance and military oath that Catholics could take, such as,

“I pledge allegiance to the USA and all its non-sinful laws; but my primary allegiance is to the Catholic God, the Catholic Church, and the papacy.”

Catholics’ first allegiance must be to the Catholic God, the Catholic Church, and the papacy or they become schismatics and heretics. A less acceptable oath is as follows:

“I pledge allegiance to the USA.”

Even though this does not include the last parts of the best pledge, those parts could be assumed because no one gives blind obedience to a ruler or country and it does not say one gives his ultimate allegiance to the USA nor that one will fight in *all* wars conducted by the USA.

Heretical immorality

By mandate, the USA military, as a general law, allows women to rule over men and fight in wars. This is against God's natural law and is immoral and heretical. It is the heresy of feminism.

By mandate, the USA military allows open homosexuals and transgenders to enter and remain in the military. This is against God's natural law and is immoral and heretical.

Hence for these reasons alone, Catholics cannot join the USA military. If they do, then they are partners in these crimes and thus are guilty of the mortal sins of heresy and immorality.

And the military is bound to give him an honorable discharge based upon his religious beliefs, just as it does with other religious groups, such as the Mormons, Amish, and Jehovah's Witnesses.
