## Introduction

William George Norris was elected as Member-at-Large in the Sierra County Republican Party on 1-14-2023.<sup>1</sup> But he was removed from office on 6-8-2023 because he upheld conservative social values. Julie Stroup, the chair of the Republican Party in Sierra County, spearheaded this witch hunt against William.<sup>2</sup>

The main point in this whole charade is that William was removed from office for daring to question Republican officeholders and those running for office about their positions on the sexual perversion of children, on homosexuality, and on transgenderism, and for threatening those who either did not condemn these sexual perversions or did so insufficiently with being voted out of office, with being exposed as hypocrites and RINOs [Republicans In Name Only], and, more, importantly, that God would punish them for sinning against the natural law and God's law.

And the worst part is that William was removed from office without being shown any law that he violated. 

With the 3A District 3 Tournament complete, Tiger Golf will send two, Logan Woods and Caleb Harland, to compete at the A-3A State Championships Golf Tournament on May 9, at the Canyon del Rio Hills in Albuquerque. Logan Woods, who finished fourth at District, is ranked number two statewide for 3A girls. Caleb Harland finished seventh at District, and is ranked at number nine statewide. Because of that, they will both qualify to compete individually at state, where they will represent the Tigers and Hot Springs High.

At District, on the course at Inn of the Mountain Gods, Caleb shot a 90, with Logan Guaderrama up next, finishing ninth with a 94. Logan Woods will play on the course. At state, they will compete through 36 holes over two days.

There were 16 Tigers from the track team competing at the 3A District 3 Meet, hosted by Cobre. The track and field qualifiers were completed and nine Tigers were on the list. They and several alternates qualified to the Albuquerque for the State Championship Meet, May 5-6, held at UNM's Track and Soccer Complex.

Coming home from District wearing gold medals were Alex Maccombe, who helped the girls in a first place District throw, Hayli Bagwell earning gold in both the 800-Meter and 1600-Meter runs. Rodriguez Reyes also earned gold in the men's division 800 and 1600-Meter Run. Both Reyes and Bagwell are also on the first-place relay teams in the 400 and women's divisions for the 1600-Meter Sprint Medley Relay.

All three each year squad also came home wearing gold medals. Of the Tiger girls were Mariah Hernandez, Tarzilia Bileva, and Alma Gutierrez, along with Bagwell. On the Tiger boy's squad, Pedro Reyes, Ethan Kalminson and Burac Palacios also earned gold along with Rodriguez Reyes.

All earned gold and now the district champions for their events. Also, those are this year's Tiger State Qualifiers for track.

Tiger whizompson at District set a few of their own personal records for their events. Showing that our Tigers are always pushing themselves to new heights. Those Tigers included Mariah Hernandez, running the 400-Meter in 1:08.97, Tarzilia Bileva, who set a personal best in discus by 20 ft with a 73-foot throw, also PR'd in Shot Put, 26.1". Alma Gutierrez improved her mark by 32 ft, running a 15:42.99 run as well as a new personal best in the 800-Meter at 2:12.76 run. Ethan Kalminson ran to a new PR in the 100-Meter running it 0:13.74, with Rodie setting her best in the same run as well. Ethan Kalminson, Hernandez and Darby Arredondo set their best in the 100-Meter at 10.30.40, 10.29.95 and 10.42.03 respectively. In the 200-Meter they ran 26.17 and 41.78 respectively.

Setting personal bests on the boys side, Mariah Hernandez set a new PR in the 800-Meter at 2:17.27 run. Ethan Kalminson ran to a new PR in the 1600-Meter. Both Ethan Kalminson and Pedro Reyes set personal records in the 1600-Meter Dash, running it in 11.75 and 11.77 respectively. Tim Maccombe and Jason Maccombe set their previous best in the 100, running in 11.76 and 12.79 respectively.

And it was the Catholic Church that said these 27 books were inspired by God. He didn't deny that.

While I was talking to Ryan and Tom, I noticed Crystal out of the corner of my eye talking to someone but as she heard us talking she left that person and stood right behind Tom and listened to what we were talking about.

Ryan then asked, are you telling me only Catholics go to heaven?





Hi All,

I know that you have been targeted as conservative influencers in your spheres to disseminate information regarding the social studies curriculum recently approved at the T or C School Board meeting. I know we heard from many of you and your congregations/constituents during the meeting's public comment period.

Since this vote has specifically caused me to become a target of some hateful and dangerous comments and threats, I thought that I should reach out to you directly and give you the benefit of my point of view in the hopes it would cause the influencers of our community to have pause about fueling discord and hate within our community.

# 200+ Attend Meeting As School Board Chooses History Books

With more people from the community in attendance for a school board meeting than most there could remember, the board adjourned from their normal meeting room at Central Services, and reconvened in the Hot Springs High School cafeteria, in order to accommodate the estimated 220 who wished to attend.

The hot button topic that brought most of those attending out was the anticipated board vote on curriculum materials for K-12 social studies and music education. Tabled from the April 26 special meeting of the school board was a decision on whether to approve those materials recommended by committee and Dr. Edgardo Castro the district's Director of Learning Services.

Recommended and discussed at the late April meeting were taken from a list provided by New Mexico Public Education Department (NM PED) of 24 publishers, narrowed down to four that were being examined in detail and that have been available for public scrutiny and comment since mid-January.

Those being voted on were, for K-5, elementary social studies Savvas Learning Company, for middle school social studies, grades 6-8, McGraw Hill and for high school, Cengage Publishing. Part of the appeal of these was the availability of additional materials, with National Geographic being part of the Cengage Group, and the History Channel affiliation

speak during the public input portion of the meeting nearly all were expressing their opinions regarding the recommended textbooks and related materials under consideration. The bulk of those were voicing their disapproval of texts. Reasons for urging the board to reject the curriculum materials were strongly expressed feelings that they did not reflect their values and beliefs. Many stated that the books contained critical race theory (CRT), and sex education, particularly discussions around topics of sexual identity, gender preference and other broadly LGBTQ topics and that they celebrated or promoted these lifestyles and choices.

Many speakers urged rejection because they felt it important that the materials ultimately used should reflect their values and faith. Most also said that teachers should confine themselves to teaching reading, writing, math and science, and that sex and race had no place in the classroom, and should be left to be taught in the home, by parents.

Several teachers who served on the committee involved in the selection of the materials stated that they saw no CRT in the books that students would be using. The district also had posed this question to the publishers and had received letters from each stating that CRT was not contained in the materials. It was further stated by those supporting the adoption of that teaching sexual orientation and gender identification were not included in the materials that the students would be using. This was disputed by many of those urging rejection of the selections. One specific passage in the text was identified that talked about celebrating LGBTQ diversity.

The large, boisterous crowd cheered loudly, showing their support of each that rose to urge rejecting the materials. For the most part, everyone in attendance remained respectful of all those who rose to speak, regardless of the position they were supporting, listening and even politely applauding or otherwise respecting contradictory viewpoints. Most objecting to approval of the selected material stated that whatever is finally decided on should reflect the values of the community and stressed their opinion that as a small, rural, agricultural community, the values of many here are different from those embraced in Albuquerque or Santa Fe or other bigger cities.

Those speaking in favor of approval of the materials stated that they had not found specific passages or sections that promoted what those in opposition said they objected to. Further, some teachers clarified that the materials under discussion, as any school textbooks, are only a starting point for how instruction is

done in real life practice, and that a variety of additional material and resources are used, as has been the case in schools for generations.

Teachers asked that their professional training, expertise and experience be respected, that they want the best possible education for students going forward, to prepare them for life after graduation, whether that be in careers, the military or going on into college and vocational schools.

In opposition, speakers stressed there were areas that dealt with values, religious beliefs and lifestyle choices that were the domain of home and family and needed to be left out of the schools.

Board member Julianne Stroup stated, as she had at last month's meeting, that there were other publishers who could supply materials that were not on the NMPED list and urged the board to take more time and look into these. It is allowable for districts to use materials from other publishers, though they would need to be properly vetted and would have to allow for teaching to the standards set by NMPED.

This year it was presented collectively to the district school's Mental Health team, including mental health counsellors, social workers and contract workers in those areas.

- The board unanimously approved a request from HOSA health occupations students' group to travel to Dallas, for the International HOSA Leadership Conference, where a number of our students will be competing in area specific judging. Two students, Bolke and Abie Dankert, will speak about the importance of this opportunity, that it enhances their education in preparation for their future careers.







## **6-8-2023: SC Republican Party voted to remove William from office**

On 6-8-2023 at 9am at the *Church at the Butte*, the Sierra County Republican Party voted 5 to 1 to remove William from his office as Member at Large. Kandie Daves opened the motion and Johanna seconded it. The five who voted for removal are Julie Stroup, Johanna Tighe, Sheridan Fuss, Jacqueline Bentley and Kandie Daves. The one who voted not for removal was William. Two other board members did not show up for the vote, Cathy Vickers and Carol Ness.

### *William's testimony before the board*

[Here is William's testimony during his trial before the board members before they voted him out of office.]

The Sierra County Republican Party has asked that this meeting not be recorded. So much for transparency! One must ask, "What does it have to hide?" Even court cases record testimonies." Nevertheless, I begin mine.

Julie Stroup, the head of the Republican Party of Sierra County is spearheading this witch hunt against me. The Party is voting to remove me from office because I questioned Republican Officeholders about their positions on homosexuality, transgenderism, and the sexualization of children. And it called my questioning, intimidation and harassment:

On 6-2-2023 Julie said: "William Norris has been sending emails to Republican elected officials attacking them with intimidation, threats and harassment."

(*Republican Party of Sierra County*, Julie Stroup, Chair, 6-2-2023)

Since when is questioning someone about their beliefs regarding social or economic issues harassment and intimidation? I said, "Since when are Republican officeholders not allowed to question other Republican officeholders regarding their positions on social and economic issues?" I said, "Show me the law?" And it never did. So it is basing my removal from office upon no law regarding this matter; and, I would add, contrary to the behavior of Republican officeholders who do oppose one another, sometimes vehemently, regarding social and economic issues.

And it said I threatened officeholders. The only threats I made to officeholders who either did not condemn these sexual perversions or did not do so sufficiently is that they would be voted out of office; that they would be exposed as hypocrites and RINOs; and, more, importantly, that they were sinning against the natural law and God. So, in practice, the Republican Party of Sierra County has banned parts of the Bible and parts of Christianity from its public forum that it does not agree with, just as the Democrats do.

It also accused me of opposing the conservative values of the Republican Party:

On 6-2-2023 Julie said: "William Norris does not speak for or represent conservative values of the Republican Party." (*Republican Party of Sierra County*, Julie Stroup, Chair, 6-2-2023)

Well, if that is not calling evil good and good evil, then I do not know what is. (See Isa. 5:20) Since when have homosexuality, transgenderism, or the sexualization of children become conservative values?

Let it be known that Rebecca Dow refused to publically condemn the sexual perversions in the proposed school curriculum. And even though Crystal Diamond was at the school board meeting regarding the proposed curriculum, she did not condemn the sexual perversion in it. She said, ““I am not here to express my personal opinion about the curriculum.””

And I asked Steve Pearce, Rebecca Dow, Crystal Diamond, and Christine Lafont if they believed that homosexuality is a sin against the natural law and against God, and they did not answer. And they have the audacity to say that it I am the one who is betraying conservative values.

In her above statement, Julie Stroup said that I do not “represent conservative values of the Republican Party.” Well, that is yet another lie. The fact is that the 2016 Republican Party Platform discriminates against homosexuality and says it is “alien to America’s history and traditions.” And the Republican Party of Texas says, “Homosexuality is an abnormal lifestyle choice.”

Hence it is I who am upholding the Republican Party’s position and conservative values in this regard and not the Sierra County Republican Party. It, then, is not only dividing the party on this issue, but also betraying it.

Consequently, it has no legal right to remove me from office regarding this matter. In fact, it and its officeholders who agree with these accusations against me are the ones breaking the law and hence should be removed from office.

Julie Stroup at first agreed with my stance against these sexual perversions. Here is what she said on 5-12-2023 regarding the sexual content of the proposed school curriculum:

Julie said “Even with the overwhelming opposition to these textbooks, Board President Christy LaFont, Board Vice- President Dr. Barbara Pearlman and Board Member Mark Hedge voted to adopt said books for grades 6-12. Board Secretary Jamie Sweeney and me, Board Member Julie Stroup voted against purchasing these textbooks for our children K-1 2... These textbooks are not in line with the values and morals of decent Sierra County residents. If we do not recruit and elect Hard Republicans to run for every office in the county, and get out the vote, we will have a repeat of that May 11th School Board Meeting in every board and commission.”  
*(Republican Party of Sierra County, A Letter from Chair Julie Stroup, 5-12-2023)*

But when Julie got heat from her superiors and other officeholders, she caved in. Instead of spearheading a recall vote for Christie Lafont, she now defends Lafont and is seeking to remove me from office. I will now expose Julie’s hypocrisy, which she says is blackmail:

On 6-2-23, Julie Stroup said “He [William Norris] is attempting to blackmail me and others stating if I remove him as a member-at-large he will, ‘expose me for the hypocrite and RINO that you are.’”  
*(Republican Party of Sierra County, Julie Stroup, Chair, 6-2-2023)*

Since when is it blackmail to expose hypocrites and point out RINOs! At first, Julie and other members correctly called for a recall vote of Lafont, but when she got pressure from her superiors and other officeholders, the recall vote was called off and instead the vote to remove me from office replaced it.

But in her 5-12-2023 letter Julie said she wants Hard Republicans, such as myself, to replace soft ones, such as LaFont, but when it came to putting her good words into action, she denied them by calling for my removal from office and defending Lafont and other RINOs. If that is not hypocrisy, then I do not know what is. Now you know why only RINOs can hold office in Sierra County and in most other place in the USA.

To conclude, this trial of me is a kangaroo court based upon no law that I violated. If you vote to remove me, then there is no hope in Sierra County to have true Republicans, Hard Republicans, to hold offices.

#### *William's report on his removing from office*

On 6/8/23 I went to the Church at the Butte in Elephant Butte NM for my hearing to be removed from my At Large Member Position for the Sierra County Republican Party. Brothers Nick and Ryan and myself arrived at the hearing at 8:55. A girl by the name of Shawn Montgomery was at the entrance door of the Church and told me only I could go in. I walked into a cubical area where they positioned the tables a certain way so that I would be facing members of the board. The people in the room were Julie Stroup, Johann Tighe, Sheridan Fuss, Jacqueline Bentley, Kandie Daves and Joshua Baker. I was glad that Josh came because he was an outside witness to see what went on. He is a trustworthy source who could confirm or deny what went on during the meeting since it was not going to be recorded. I was glad that he got hear my speech. Later Shawn Montgomery came in and was the time keeper for my speech.

The meeting began at 9am. Johanna spoke first. She said: "I recruited Will and he has been a huge help for the party. He has been a workhorse, done a lot of grunt work for the party. He helped my husband Ken chop weeds at the Republican Headquarters. He helped set up the booth for the County Fair. He organized the people to come out for the school board meeting. He did a lot of good things for the party. However, his comments on the emails he was sending out concerning Rebecca were over the top, and then he showed a blatant disregard for the rules when he recorded the last Sierra County Republican meeting when he was asked not to do it." I thought to myself that that never would have happened if Rebecca would have publically condemned the sexual perversity in the first place.

Julie reiterated the points that Johanna made by saying that "Johanna has expressed most of what I was going to say, but then she added, "We have to build the party up and support our elected officials." She said Rebecca is our Republican District 2 Representative and have to show her respect. She's an elected official and we can't attack her. We have to help them win. This saddens me to do this because I really like you."

When I gave my speech, I didn't get to finish the whole speech. I had three sentences left. My last words were "Kangaroo court". I felt like St. Stephen when he gave his speech condemning the apostate Jews in the Book of Acts and they couldn't stand to hear any more. They did not give me 10 extra seconds to finish my speech. When the five minutes was up they immediately shut me up and I couldn't say anymore. That is beside the fact that I asked Julie if I could have seven minutes, and she said no. If it were up to them, I would not even get one second to testify.

Because the speech nailed them for not having a law on their side to remove me, Johanna started off by saying "The main problem I had with you was that you disobeyed about the recorder." Julie tried to say the same thing and then I asked Julie, "Oh so this whole thing is about the

recorder and not about Rebecca?" She said no, and then shut up right away and said nothing more. Sheridan Fuss said "I thought you would have been more defensive in your speech and not so attacking. You were attacking." I said, "Because the law is on my side on this issue." He didn't know how to respond to that. The other two members, Kandie and Jacqueline said nothing the whole time, they had their mind thoroughly made up and were not going to listen to any thing I said no matter how true it was.

When they took the vote, Kandie Daves opened the motion and Johanna seconded it. The vote was 5-1. I was the only one who voted for myself. After the vote, I walked outside with Josh Baker and we met up with Brothers Ryan and Nick. We had a good talk with Josh and he was listening. I told him how Rebecca had no excuse not to condemn the curriculum being that she is an educator and has a lot of political clout in Sierra County. I said that she should have been the first one to condemn this curriculum at the school board meeting. I said if we don't block this curriculum now than next year we're going to be like California and have books with graphic sexual pictures in it. I said the main reason is because she has LGBT friends and she does not want to offend them. Br. Ryan jumped in and said if it wasn't for Will getting the ball rolling on how bad the curriculum is no one in the county would know about it and we wouldn't have had a protest of the school board meeting. He also inquired about why no one is following up on the recall of Christy LaFont,

As Julie was leaving and walking to her car, I asked her what was going on with the recall vote for Christy LaFont; and she said she didn't know anything because she claimed they don't tell her anything because she is a school board member. It is funny how NOW she is totally "cut out" of the loop because before she knew everything that was going on with it. She even told me that if I ran the recall to get rid of Christy, I would have to resign my office and she would work with me in the background with and re-instate my office when the recall vote was over. Well, I believe they were using the recall to try and get me to resign so they would not have to look bad by removing me from office. It was a big setup because Rebecca Dow was at first the head of the recall and now it has been buried. I told Julie "Now the recall has been swept under the rug and I'm the scapegoat for this whole thing." I asked her if she remembered how she told me before the school board meeting that she said that Rebecca should testify against the curriculum because she is a Christian. She said nothing the whole time. Then when I tried to find out what is going on with the new K-5 curriculum she replied, "I have a lot going on today and I have to leave." As she was leaving she asked "Are you recording me?" I said no. I later that day emailed her the same question again about what is the status about the new K-5 curriculum and she has yet to answer me back. She's probably been told not to deal with me anymore.

When I was getting the word out to other Republicans about my removal, I found out an interesting piece of information. A woman I know said that she was in the bathroom at the last Sierra County Republican meeting right after everything went down about me asking my question to Rebecca. She said that Julie and Rebecca came into the bathroom and were gloating about how Rebecca shut me down when I was questioning her. When they realized that she was in the bathroom, they immediately shut up.

After the meeting, I looked at the Sierra County Republican Face book page and I noticed that they removed the two posts that were condemning me and our comments to the posts. I was telling Richard that now that I am removed they think they remove the posts and bury this whole incident. Not so! We are going to put a full page ad in the paper on 5-16-2023 and post my speech that I gave at the hearing. I'm hoping we will get some feedback from this. Stay Tuned!

### **6-9-2023, Letter to Editor: Will Norris’ Sierra County Republican Party Betrays Conservative Values**

[Note by RJMI: This letter had to be submitted to the Sentinel by 5-6-2023 and thus before the vote to remove William took place on 6-8-2023. However, the letter was posted in the paper on 5-9-2023. Also William was not told they were going to vote to remove him from office until 6-2-2023, the same day the paper came out, always on Friday. And the vote took place before the next edition of the paper. I believe they did this so that William would not be able to put an ad in the paper asking for those who support him regarding this matter to show up and protest the vote. So William had no chance to do that. Also they held the vote to remove William at 9am in the morning so that many who did want to show up to support William would not be able to because they would be working. And they even took more precautions because the only people they allowed in the meeting were the board members and Sheriff Joshua Baker. Baker was the only independent witness to what had occurred. And they forbid William to record the meeting. And to his knowledge, there is no record of the meeting and thus of the statements that were made. So when William wrote this letter, he knew they were going to vote to remove him from office, but the vote did not yet occur.]

My Conversation with Steve Pearce at the NM Republican Legislature Dinner in Santa Fe

On 1/20/23, I attended the NM Republican Legislature Dinner at the Eldorado Hotel & Spa in Santa Fe.
