## **DOG ATTACK IN ELEPHANT BUTTE SPIRALS INTO MONTHS-LONG BATTLE FOR**

**ACCOUNTABILITY** What began as a routine walk on February 16, 2025, has turned into a months-long ordeal for Blain, a visiting Canadian staying at a campground in Elephant Butte, New Mexico, after a vicious dog attack left his 20-pound pet, Taco, seriously injured - and animal control's sluggish, inconsistent response has left the community seething.

From the initial violence to the dog's reappearance on March 24, the saga has exposed gaps in enforcement and fueled demands for justice.

# THE ATTACK:

## **FEBRUARY 16, 2025**

Blain was walking Taco and his other dog, Georgie, near a property just up the road from his campground at the corner of Roadrunner Circle and Hawthorne - a route they'd taken countless times without issue when chaos erupted. Taco, an amazing little dog adopted by Blain and his wife from Desert Haven Animal Rescue while on holiday here, became the target.

A white bull terrier-type dog with a brown patch on its head and side charged across the road. "It went straight for Taco," Blain said. "She's only 20 pounds - this thing was over 70 pounds and tore into her stomach." The terrier flipped Taco upside down, thrashing her as she screamed in

Its owners shouted commands, but the dog ignored them entirely. Blain struck the attacker while one owner wrestled it to the ground, prying its jaws open to free Taco.

Taco sustained severe abdominal wounds, requiring emergency surgery, an overnight vet stay, a drain, and stitches. "It was a nightmare," Blain said. "She's been healing ever since."

Desert Haven Animal Rescue responded faster than animal control, arriving at Blain's campground within 20 minutes of his call with dressings for Taco's wounds and painkillers to tide

Unfortunately, there's no emergency vet in Truth or Consequences, and the closest option was in El Paso, Texas. Blain got her to Arenas Veterinary Clinic first thing Monday morning for treatment. Animal control was also called, initially stating that the homeowner is responsible for any dog on their property, regardless of ownership.

But when the homeowner denied knowing the dog or its owner, officials didn't visit until the afternoon of February 17 nearly 24 hours later - giving ample time to relocate the ani-

**AND EARLY FRUSTRATION** Skeptical of the homeowner's denial, Blain posted about the attack on Facebook, sparking a flood of responses. "Over 30 people came forward," he said. They've seen that dog at that address, had problems with it before, and reported it to animal control." Residents provided accounts of the terrier's aggression and its repeated presence at the property, contradicting the

homeowner's story. Yet, animal control deemed the witness testimony insufficient to act, leaving Blain and the community stunned. "The homeowner lied, and the delay helped them cover it up," believes Blain.

## A STALEMATE PERSISTS

For over 30 days, the case stagnated. Taco slowly recovered at home, but no resolution emerged. Animal control maintained that without definitive proof of ownership, their hands were tied – despite their own policy holding homeowners accountable and the dog's documented ties to the address.

They know who lives there, and the law says they're responsible," Blain said. "But they're doing nothing."

The Dog Returns: March 24,

On March 24, 2025, a resident spotted the terrier and its keepers back at the property and alerted animal control. Blain received a call from officials saying they'd "head out there" in about an hour - a response time he called "pathetic."

Checking the property while on the phone, Blain found it empty; the group had evidently moved to a friend's house down the road. Animal control then claimed that, since over 30 days had passed, their options were limited. When pressed, they added that if the dog leaves Sierra County, it's out of their jurisdiction – despite knowing the homeowner's identity and the law's clear stance.

## **LEFT HANGING**

The back-and-forth has eroded trust in Elephant Butte's animal control. "They're hiding behind delays, excuses, and jurisdiction," Blain said. "That dog's a threat it ignored its owners' commands and could've killed Taco or attacked a kid."

Residents continue to report sightings, but faith in action is fading. "I was lucky I didn't have my 5-pound poodle or my grandson with me that day," Blain added. "It was traumatizing for me and still is. I now walk with a bat and mace."

Blain emphasized that his fight isn't about money. "I'm not asking the owner to pay any vet bills we don't care about that," he said. "What we care about is that this dog is dangerous to other people and animals and should be held accountable."

Adding to the irony, Blain's wife is an advocate for animals and the laws surrounding animal abuse and neglect. "It's unbelievable this happened to our own pets," he said.

He remains focused on Taco's recovery and broader safety. "The community's stepping up because the system isn't," he said. "Thirty days later, and they're still dodging. Someone has to answer for this.

Animal control says the investigation persists, but with the terrier now shuttled nearby and no enforcement in sight, the ordeal feels far from over. Authorities

## THE HOLOCAUST **WAS A HOAX! PART 1**


