### THE NEW COVENANT REPLACED THE OLD COVENANT

It was prophesied during the Old Covenant era that God would make a New Covenant that would replace the Old Covenant: The Prophet Jeremias says, "Behold the days shall come, saith the Lord, and I will make a new covenant with the house of Israel and with the house of Juda. "Not according to the covenant, which I made with their fathers." (Jer. 31:32)

Then said I: Behold, I come to do thy will, O God: he taketh away the first [the Old Covenant], that he may establish that which followeth [the New Covenant]. In the which will, we are sanctified by the oblation of the body of Jesus Christ once." (Heb. 10:8-10)

"But now he [Jesus Christ] hath obtained a better ministry, by how much also he is a mediator of a better testament, which is established on better promises." (Heb. 8:6)

"Jesus [is] the mediator of the new testament and to the sprinkling of blood which speaketh better than that of Abel." (Heb. 12:24)

Jesus compares those who try to mix the Old Covenant with the New Covenant to those who put
