

If TJ Had Repented and Confessed, this Condemnation of Him Would Have Remained Private (2/14/2025)

On 2/14/2025, I gave TJ this warning:



The Major Incident (2/1/2025)

The major incident that led to TJ being placed under a minor excommunication and then leaving the Catholic Church took place on 2/1/2025, the 7th weekday, when all the brothers were online getting ready for the monthly Exorcism Prayer. Br. Declan, Br. Matthew, Br. Matheus, and TJ were looking for places to live in Ireland, in Northern Ireland or Southern Ireland. TJ was making trouble regarding these plans by not listening to others, by leaving others out of discussions, and by pushing his will in spite of evidence that proved his plan was not workable and in spite of the fact that the other three did not agree with him. This is when Br. Declan sent me a letter saying that TJ was disrupting the plans.

Declan 2/1/2025 1:31 AM

Hi Br Richard. Praise be Jesus, Mary and Joseph. I hope that you are doing well at this time.

I am writing in relation to the Irish Church and our plan to start a new community. Over the past few weeks Br TJ and I have been working hard to get a place that suits all current Irish members and Europe. I am writing today as I'm concerned, Br TJ is getting excited about the new community – as we all are, I fear that although he has taken the lead on the project, he has no experience in organising a new house for renting and at times isn't understanding of a real image of the current market. This is impacting his decisions on the best time to move.

I am messaging as I want to meet him half way. Things change quick and my original plan when I messaged you has transformed into a new idea, one I cant at the moment see being a reality regarding affordability and availability of houses/jobs in Virginia (nearby Nickoline) - For example: currently there are just 3 houses on the market in Virginia and they are on average €300 per month more expensive than in the North of Ireland. If there were more members with each providing income this could be affordable and a landlord would most likely take us on but, for now it is just myself that can put my name on the house and therefore, we just have 1 proof of income. TJ has income but, it is not a possibility for him to apply for a house in his government welfare situation. Also, Virginia is a remote town (1 hour from Dublin) with little employment opportunities, unless the Brs can drive a car but at the moment it is just myself that has a driving licence. Nonetheless, TJs plan is a good idea however, I believe all this may be possible to achieve in 2 years when we get the time to organise. I still think God has a plan regarding us here in Ireland. (edited)

I have a suggestion that TJ continue with the Virginia plan, but to extend it out to a 2 year plan.

In the immediate term I would suggest myself to organise a slightly larger and affordable house up the North to accommodate one or two visitors if they need a place to go. This I see manageable. As being the only member to be able to put a name on the house it will be easier for 1 man to do this up north of Ireland because demand is less and availability is high.

This would be a good platform too for Br Matthew and myself moving over and back from NM, or anyone in Europe if they need to go somewhere temporarily for any reason.

We can then make plans for moving south towards Nickoline over 2 years and, give Br Mattheus, if they decide, a bit of time to organise his family moving.

It would also allow my delivery work to continue as I move into these opportunities which are widely available in the North and that it is keeping me away from spiritual attacks.

Through Jesus, Mary and Joseph. (edited)

I am unsure of Matheus's current commitments to moving though I believe he is now enquiring about visas.

I know how TJ is in these matters. Many times he presses his point without proper consideration of all the facts and without proper consideration of others. So after I got this message from Br. Declan, I decided to settle it online when all the brothers involved are present so I did not have to go back and forth with messages, which takes a huge amount of time. So on 2/1/2025, just before the monthly Exorcism Prayer, I brought this up online and we discussed the plans. TJ was only pushing his plan and did not want to take into consideration other plans or the situation of the other brothers. He was even promoting plans that were manifestly either impossible or extremely inconvenient. When plans that could work were presented to him, he rejected them and came up with one excuse after another, some that did not even make sense. For example,

- First some facts, TJ's home address is in Dublin in Southern Ireland. He is on social welfare and not allowed to live outside of Southern Ireland. The house he is living in with Br. Declan is in Northern Ireland in Derry. Hence he has to keep this secret so he can continue to collect social welfare.
- The rent in the apartment is low. It is \$600 per month. But it was too small for three and was moldy. So they were looking elsewhere for a bigger and better place that they can afford.
- At first, they were looking for a place to live in Southern Ireland. But the rents were twice as high. So I said keep looking maybe you will find one you can afford. At first they wanted to live near Sr. Nicoline who lives in Southern Ireland in County Cavan, which at first sounded good if they could find an affordable place. But Sr. Nicoline said all the rents are double compared to the North. And she said that County Cavan is far from a big city (Dublin), and thus the brothers would have to go a long way to work and it would cost more money for travel. Sr. Nicoline said men living County Cavan who drive or take the bus to work in Dublin leave at 5am and are not home until 7pm, pending on what their jobs are. I told TJ that for this reason alone it will not work because Brs. Declan, Matthew, and Matheus would have to travel this every day and will cost extra money, on top of the higher rent. So this ruled out that option. But TJ refused to listen. He kept punishing for it because it fit his plans and way of life, because he does not work a job and has social welfare that he collects in the South. He was only thinking of himself.
- Taking all this into consideration and the opinion of the others involved, I said it is best for now to look for a bigger better place in the North until something opens up in the South that can work. TJ did not like that. He wanted to stay temporally in the smaller place in Derry that he and Declan were living in. I said, why would you want to stay there if you can find a bigger and better place at the same price or a little more. He said he may not be able to afford it. So I said, well, then, only move into one you can afford. Then I said what if you found a place for the same price and was bigger and better? He said he still did not want to move because he can work with his current landlord. What he meant is that the current landlord is not nosey and thus does not know he collects social welfare. So I said, only move into a place in the North that you can afford and in which the landlord is not nosey. He still said no.
- Here comes his next excuse. He then said the place he is living in is a good neighborhood. He said, what if the place we move to is a bad neighborhood. I then said, well then only move to a place where the neighborhood is good.

- He then came up with another excuse. He said the laws in the North are stricter regarding the banning religious liberty for conservatives. But he admitted that the South is now almost as bad. But if the one place has worse laws than the other, then they could just arrest him when he goes to Northern Ireland to collect the welfare, or vice versa. That is beside the fact that they have been living in Derry for some time now with no problems.
- He then came up with another excuse. He said if we are going to eventually move to Southern Ireland and work there, then the brothers who get jobs while living in the North will have to leave those jobs. I said, "Yea, that is what happens when people move to another location. They leave their current jobs and get new ones." I could not even believe he came up with this one.
- Also during this conversation, TJ tried to shut down the conversation several times by saying there are certain private things that affect what he can do and thus did not want to talk about the plans in front of everybody. I said, you are all online now and I want to solve this with all involved. I know what his private matter was. It was the social welfare he collects from Southern Ireland, and he is not allowed to be living in Northern Ireland in Derry in the UK. But everyone online knew he was on social welfare. This was the reason he wanted to move to the South or stay where he was because the current landlord is not nosey. This so-called private matter he kept brining up was a ploy to stop the conversation with the others.
- During the conversion, TJ got progressively upset, disrespectful to me and others present who had to listen to him and his one-excuse-after-another and not really listening or taking into consideration all the facts, and going on about things I already covered as if I did not already speak of them, forcing me to repeat myself several times. And this went on-and-on and on-and-on to the point that some of the brothers just told him to shut up already. But he did not. He just kept going on and on. That is when I stepped up and said to him. "You put your foot down, and I put my foot down. And my foot is bigger than yours. Now shut up."
- Well this is what pushed TJ over the cliff in his pride and rebellion. Not only does he not really like it when someone gives him counsel, he hates it when he is commanded to do something, to obey. And he hates it when he is publicly admonished. This is just more proof of his pride and rebellious nature and the trouble he has in accepting the dogmas on slavery and capital and corporal punishments. He may pay lip service to these dogmas, but he denies them by his actions.

The Brothers Condemned TJ and His Insincere Apology

All the brothers were appalled, disgusted, and exasperated by TJ sinful behavior, and some condemned him for this on the chat site. He then began to attack them, as if the condemnations were unjust. He played it off as if it was a minor matter. I then told him that he was to apologize for his sinful behavior to all the brothers whom he accused of sinning for justly admonishing his sinful behavior. He did apologize, but insincerely, as he went on attacking those who justly condemned him. He said they were provoking him.

Thank you God for showing us this arrogance and down right bad behaviour. Please so we can move forward and show some good will here in Ireland have the humility to accept your bad behaviour. in the Love of Jesus Mary and Joseph, thank you saint Brigid—

We need leaders now and full commmitment, end off.



No I am ok, I am happy to be able to say this now, I will fully accept and forgive if I see humility and acceptance of bad behaviour. As I said brother we owe so much to brother Richard and tonight disturbed me. Who are we without God's Grace, remember if he pulls them from us who are we. Anyway it is late here. Dominus vibiscum

The main proof that his apology was insincere is as follows. The day after the incident, Br. Declan posted this on the Chat Site:



Well, TJ went off the rails after that. He messaged Br. Declan and put the blame on him. He wanted Declan to defend his sinful behavior and to remove his above post from the site. And TJ pretends the whole incident was private and thus not online for all to hear. He also pretends that others do not know about his other public sins, which are manifest and obstinate.

TJ and Br. Declan, 2/2/2025::

"T.J: Brother, I apologised to Br. Richard and to the group for being disrespectful. Regarding moving place, you know full well I was on board with moving to another place for the 1st two weeks when you arrive. And you know the headaches you and Matthew especially, put me through for weeks. Last night, you did not come to my defence sufficiently, far from it, and I am very disappointed in you. If you don't you will answer to God. Remove your public post and deal with me privately.

"Declan: It was a public discussion, brother, and I will answer publicly... The only solution to solving what I believe are sinful problems is getting a job as Richard said. I won't remove my post because it needs to be said. If there are concerns it needs to go to brother Richard as for now I believe I am good standing point. I know it must be difficult at this time, and I'm praying for you a lot last night and today.

"T.J.: ...I apologised for me being disrespectful to Br. Richard, that's it. Everything else I will deal with privately. You are lying to me and to the group, if you do not repent, you will end up in hell...I'm not even going to discuss this more, remove the post, stop inflaming. Or I will consider you an obstinate liar to be avoided, and I will know, you have absolutely no care for my soul. Apoc. 21:8 "But the fearful, and unbelieving, and the abominable, and murderers, and whoremongers, and sorcerers, and idolaters, and all liars, shall have their part in the lake which burneth with fire and brimstone: which is the second death."

"Declan: I am referring to the general behaviour that Richard had correctly stated last night. The only solution is to get a job.

"T.J.: Just one example of your lying "I need you to work with me this time." You are a liar, and Im not going to debate that. It is very clear, you were warned. Regarding getting a job, you are deflecting from your lies. I already agreed to find a

job. To believe that is an issue is not to forgive. Compound your sins if you choose. General behaviour, I have actually no idea what that means, and I was hoping to talk to you, Matthew and Nickoline privately, as it should be done, for the sake of my soul, as it should have been done. Granted you did come to me about issues you had and I don't ignore that. But when did Br. Matthew, when did Sr. Nickoline? That is is not right and you know that. You are also inflaming and supporting a comment made by Sr. Nickoline 'I am very disturbed by your behaviour over the last few months.' Remove the post. I will not have anything to do with obstinate liars."

After this correspondence, Br. Declan sent me this message:

Br. Declan, 2/2/2025: "I believe Br Richard, with your permission on a temporary basis, for example 6 months, I take the leadership role of the Church in Ireland. For now, Ireland needs someone at the head under your leadership which I have experience with doing in my previous temporal work. I have the ability to take everyone's considerations into account and take action on decisions that have Gods plan for Ireland and NM in mind. All of which would be in line with you and God's direction. Overall this will govern Ireland under you and God. It gives us the opportunity to make the next steps. Final decisions on a new house can be made, taking into account everyone's considerations."

I told him, yes. He is now the ruler of the Catholic Church in Ireland. And I announced this the same day (2/2/2025), the Fourth Lord's Day after Epiphany, to all before the Mass prayers. And TJ was online. Well, this too, must have driven him mad. There was more said between me and Br. Declan, of which I clearly saw the hand of the Holy Spirit guiding him.

I Told TJ if He Did Not Re-Apologize He Would Be under a Minor Excommunication (2/2/2025)

This correspondence between TJ and Br. Declan was manifest proof that TJ apology was insincere. So I posted on the Chat Site the following:

RJMI, 2/2/2025: "I have some bad news, Br. TJ's confession was totally insincere, as you will see in this correspondence he had with Br. Declan. He is even worse than I thought. He is condemning Br. Declan instead and trying to force him to commit a sin of omission and also a sin of commission by defending TJ's sinful behavior. This is sooo bad."


And here was my warning to TJ:

RJMI, 2/2/2025: "Br. TJ, if you do not sincerely confess and repent and apologize to Br. Declan within one week, you will be under a minor excommunication and thus I will ban you from the site. If you want to communicate with me you can do so by DM. I will let you online today for Mass prayers but I will mute your mic, and I do not want you typing in anything during Mass prayers, announcements, and lecture. I leave you with my one of my daily Bible readings:

'And we beseech you, brethren, to know them who labour among you, and are over you in the Lord, and admonish you: That you esteem them more abundantly in charity, for their work's sake. Have peace with them. And we beseech you, brethren, rebuke the unquiet, comfort the feeble minded, support the weak, be patient towards all men.' (1 Thes. 5:12-14)

"The unquiet... That is, such as are irregular and disorderly."

The dead line was 12pm Ireland time on the 7th weekday (2/8/2025). Well, he did not confess. Instead, he waited for the last moment, 11:45pm NM (4:45pm Ireland time) time, to send the following dramatic, sappy, and effeminate message. I am mostly referring to the song.



So it appeared as he left the Catholic Church altogether on his own, as most do.

"They went out from us, but they were not of us. For if they had been of us, they would no doubt have remained with us; but that they may be manifest, that they are not all of us." (1 Jn. 2:19)

I decided to give him one more week to come to his senses and sent him only a Minor Excommunication Decree to see how he would react. I send it at 11:48pm Ireland time. What follows is that Decree:

He Incurred a Minor Excommunication (2/8/2025)

The Holy Catholic Church

302 East Joffre St. Truth or Consequences, NM, USA

2/8/2025 (4:48pm MST) St. John of Matha

Br. TJ Delaney,

You are under a minor excommunication for mortal sins against the moral commandments for selfishness, pride, laziness, stealers of others time (inconsiderate of others time), rebellion, spoiledness, disorder in your life, and a disrupter of Catholics who live with you or are otherwise in your company. If you die as such, you will be damned to the everlasting fires of Gehenna. If you do not repent and publically confess before six months, which is by 8/8/2025, you will incur and automatic major excommunication from the Catholic Church, and thus you will no longer be Catholic. But if you commit a mortal sin against the faith or schism before that, you will incur the same. Most who do not repent and confess end up falling into one or more heresies or schism.

No Catholic or anyone on the Chat Site is allowed to talk with you or read your messages. If you send them a message, they will delete it without reading it. The only message I will read from you regarding this matter, is your repentance and confession.

To the brothers, "Now I have written to you, not to keep company, if any man that is named a brother [Br. TJ], be a fornicator, or covetous, or a server of idols, or a railer, or a drunkard, or an extortioner: with such a one, not so much as to eat." (1 Cor. 5:11)

"And we charge you, brethren, in the name of our Lord Jesus Christ, that you withdraw yourselves from every brother walking disorderly, and not according to the tradition which they have received of us.... "And if any man obey not our word by this epistle, note that man, and do not keep company with him, that he may be ashamed:" (2 Thes. 3:6, 14)

But if business requires you to contact me or one of the brothers or site members, you can DM or email me and I will be a go between. The only exception is when you contact Br. Declan to pick up your stuff from Derry, as you will no longer be living there.

Lastly, one proof of your repentance is that you will have a job, be under a boss, and keep regular hours. If you repent and confess, I will then give you a penance.

He Incurred a Major Excommunication for Schism and His Sins that Led to It (2/8/2025)

Well, his leaving the Catholic Church was clearly manifest in the following email he sent to Mr. X, a member of the Catholic Church, on 2/8/2025, about ten hours after he incurred Minor Excommunication. He tried to lure him out of the Catholic Church and into his Church.

TJ's Email to Mr. X, a member of the Catholic Church

From: T.J. Delaney >

Sent: Saturday, February 8, 2025 9:56 PM To: Mr. X

Subject: Richard is a heretic. You sin by commission to not listen (obviously if I can proof it, and it is heresy to say I can't). Your soul is in grave danger.

Mr. X, I know you know that the last weeks events, something is not right - your emojis gave it away, you were keeping distance on the Irish picture page, and you were the only member that did so. That's why I message you, there is natural law there, I believe - it is obvious to anybody paying attention to the natural law something is not right at MLR. I do know today you decided to approve of Richards messages in the Irish picture page, I'll let that slide because Ive done it myself before (I too was a heretic). I'm not a mind reader, you could be bad willed for all I know. I hope and pray to God you're not.

The last week I have been at peace that Ive never known. I can see through Richard for what he is now. We were never Catholic. To cut straight to the point, it is heresy to not allow people to examine evidence of sin/heresy against a ruler, it is that simple. And this was before my "minor excommunication", as he said he would not listen to anything but "if you are preparing a tome to excuse your sins, save yourself the time and more importantly save me the time, because if you do I will not read it nor any of the brothers". Therefore he is commanding to the group to not listen, to ignore my explanation, including possible accusation of sin/heresy. This is to put himself above the faith, and thus is also idolisation. We were all idolaters, as he did the same with others that left or were kicked out. Also, and very importantly, to command someone to not look into sin/heresy against you, it is not only heresy but one against a basic dogma, because it is teaching that one is above the faith, but also that a man (or even a non-Catholic) is incapable of exposing a heresy/ sin - we all knew he does this, therefore we were never Cactholic!

Now, all of them who left to my knowledge had terrible excuses or were clearly heretics, not to mention coward into the night (naturally if they had any conviction, they would try to "expose" Richard -1 am very different, I am at war now, he has no idea whats coming. Now, obviously Richard knows a lot more about me on the faith, but that does not mean he can implement the faith better. It is obvious with what happened that night, what he didnt correct Nickoline on for example, and during the week that he is incompetent in leading people, I know I can implement it better, it is evident by this email alone. I have got many more sins to expose, with actual proof, and a few more heresies, with actual proof.

It has to be said, in regard to my sins/faults. There was one sin proven to the group (the rest hearsay - some, now that he finally elaborated and documented in the minor excommunication, I am all ears, and I would have gladly addressed each if Richard came to me personally in patience

and charity as all Catholics should - not gish galloping me in a heated discussion where he was pushing me out of my home (begs the question why were these things not brought to me privately 1st if mortal sins, he must of had a spontaneous revelation [sarcasm], but, even then, why online like that, I can't even fathom it) - not that it excuses my disrespect, but he did commit the sin of provocation - the natural law would tell you that when at the very beginning I said "I have personal stuff to talk about [finances, and home]", nobody should ever push a person into exposing their private info, but that's exactly what Richard did, not to mention online, not to mention in front of non-Catholics, not to mention it could have been recorded, thankfully not. Not once did anybody come to me about these "sins", that should scream at you "this is not Catholic". The one sin proven against me (as far as you know) was my disrespect to him, and I apologised sincerely. And in no way was I trying to get Declan to commit the sin of omission/commission. He lied twice, and I specifically referred to one of them. He is an obstinate liar. I don't know how Richard interpreted that I wanted Declan to sin, and I cant fathom how it didn't click with him, that maybe, just maybe Declan was lying (which I can prove).

There is so much more, but that is enough. [I had a message for everyone individually, but I believe very likely none will listen, as Richard heretically ordered them to not even look -1 will send it to you now if you want it]

Do I have your attention? Do you want to see the extent of his sins and heresies?

Obviously sooner the better, I do not want to be alone, but I will if needs be, God is on my side and I am going to do my best to bring the truth to people so they may save their souls. I recommend a phone call on Discord. You have plenty of evidence already here, and you know you are in a state of damnation, do not tempt God. But I do not want you to worry either, just follow the truth as you have done up till this moment, like any inquirer, you will be protected if good willed. Richards work is done, but he does not own it, God does. I will be leader of the Catholic church. I will be a catechumen on Ash day, and members will be accepted on Pentecost.

[PS.I am worried about Phill the most, he is not well (he only tells certain people) and I know he is too loyal to disobey Richard sinful commands. I believe he has put up with many years of, frankly, bullying, and is numb to it all - but you can tell there is a good heart there. So much damage, but I know Gods will be done]¹

Yet I tried to be fair to him, it is important to be firm with your subordinates, but he is right, Richard goes way too far, way over the top, and just not Christ like, and on many things]

RJMI's Reply

So TJ has now accused me of being a heretic and all who are under my authority as non-Catholics. It is strange that from up until I admonished him on 2-2-2025 and warned him on 2/8/2025, I was not a heretic but the spiritual leader of the Catholic Church, defender of the Catholic faith, and a good Catholic. For example, on 1/12/2025, about three weeks before he left the Catholic Church on 2/8/2025, he said this:

TJ, 1/12/2025: "Thank, you Br. Richard, but I can do nothing without your work to lean on, the infallible truth, the pearl of great price."

Now, all of a sudden, I was and am a heretic and not Catholic, as well as everyone under my authority. One wonders what took him so long to find out I was not Catholic! He is like a spoiled brat kid whose goes into a temper tantrum when his candy is taken away.

If he believed I was a heretic, he could have brought it up to me or on the site at any time. And I would have addressed it. And if I were a truly a heretic, I hope I would correct myself, as I have done in the past. And if I were not a heretic, then I would warn him that he is the one who is a heretic, show him why; and if he did not accept it, he would be a formal heretic.

Notice what TJ said to Mr. X:

"But I do not want you to worry either, just follow the truth as you have done up till this moment, like any inquirer, you will be protected if good willed. Richards work is done, but he does not own it, God does. I will be leader of the Catholic church. I will be a catechumen on Ash day, and members will be accepted on Pentecost."

He tells Mr. X, who is a member of the Catholic Church under my authority, that he has the truth (the Catholic faith) but is nevertheless not inside the Catholic Church. He has to now become an inquirer and then a catechumen before he can enter the Catholic Church. But he never tells him what his sin was that placed him outside the Catholic Church. If he has the truth, then he has the Catholic faith and thus could not have fallen out due to heresy. At best he can say he is guilty of mortal sins against the moral law and is a bad Catholic.

Also he believes the peace and security he now has is from God. He said,

"The last week I have been at peace that Ive never known."

God has allowed the Devil to deceive him by a false peace because he would not obey the truth. He is under the Operation-of-Error Curse:

"Whose coming is according to the working of Satan, in all power, and signs, and lying wonders, And in all seduction of iniquity to them that perish; because they receive not the love of the truth, that they might be saved. Therefore God shall send them the operation of error, to believe lying: That all may be judged who have not believed the truth, but have consented to iniquity." (2 Thes. 2:9-11)

If he judged things truly according the full deposit of the Catholic faith and the way good Catholics are to act and behave, he would know his peace is a deception from the Devil. This verse applies to him:

"For when they shall say, peace and security; then shall sudden destruction come upon them, as the pains upon her that is with child, and they shall not escape." (1 Thes. 5:3)

The reason he is at peace is because he can now sin and sin often and boldly without anyone looking over his shoulders. He can stay up most of the night, sleep late into the day, not work a job, and sit on his ass the rest of the day with no one to indict his conscience.

So what is my heresy, according to TJ? He says I am heretic for not allowing him to defend the accusations against him. Well, even if that were true, that is not heresy but a sin against the moral commandments. But it is not true! I admonished him many times about his sins that I listed in the Minor Excommunication against him; most times privately. But several times publically, even several times on the site. And many others have admonished him also.

In fact, on his recent visit to NM and Mary's Little Ranch from 10/192024 to 10/28/2024, I publicly and privately admonished him. For example,

- The first day he got there, Br. Will said to them it would be good to pray together, which included Prime at 7pm. Well TJ said to Br. Will, "do not put me under your whip, I am just visiting." Well, him not wanting to pray with them would have been OK. But the reason is that he goes to bed late and wakes up late. He was only there for one week. He should have been able to accommodate for one week and offer it up as penance. He then complained to others. He said Br. Will's schedule is crazy, as you will read in Sr. Nicoline's testimonies.
- When all the brothers came together to watch a movie at 7pm, TJ remained on the porch (I think smoking a cigarette), and did not come in for at least 10 min. I said, "What is he doing?" He then came in, and I admonished him for stealing other peoples' time, for not being considerate of other peoples' time. And right after I admonished him, he went right back outside to the porch. And that was a sin of rebellion and the sin of acting as if everything revolves around him. I then admonished him even more severely. He does not have the least consideration of others and their time; and when he is admonished about it, he does it all the more. The brothers who were with him on the trip thanked me, as he has done the same to them. In fact, all the brothers or anyone else who was in TJ's company for any length of time can testify to this. They even missed a plane flight because of him.
- I saw how serious and disruptive TJ sins were. So I was going to privately admonish him. I did not have to go to him, he came to me for counsel. And then I told him that unless he gets his life in order, he will not be able to be a leader in the Catholic Church and may even fall outside the Catholic Church. He said, "Are my sins mortal?" I said, "I do not think so. But if you do not amend your life when you go back to Ireland, they will surely be mortal." I told him that he must be on regular hours, as he sleeps most of the day and stays up almost all night, mostly playing poker. I told him he can play poker during the day instead. He said all the games are at night. I told him, you mean to tell me that most people play poker from between 12 pm and 5am in the morning? And I said, even if they did, you could still find some games that are during the day.
- Also, during his visit, when we all came together for movies and song, we ended it at about 10:30pm, which is about as late as we stay up, TJ said he was just beginning. I took note of that and mentioned it to him in my private admonishment of him. I said, you do not need to stay up all night to play music.

You can start your music earlier and end at a proper time. I said, for example, if you want to play must for three hours, fine. You can start at 7pm and end at 10pm. You do not need to start at 12pm and end at 3pm.

- And during that private admonishment, I told him he must be considerate of others time and of others needs.
- After considering his behavior, I did not want him to be the head of the Church in Ireland. So on the last day of his visit, I told all the brothers that TJ was no longer the head of the Church in Ireland and said all the brothers are on equal terms. I did this out of concern for the brothers in Ireland whom TJ was scandalizing by his bad behavior.

When he returned to Ireland, he did not amend his life and began to attack Br. Matthew for not wanting to live in Derry. Br. Matthew's concerns were valid. He said the place was moldy, which was not his main concern, but that it was too small. And that was true, it is too small for three to live in. And even if none of this were true and thus Br. Matthew simply did not want to live in Derry, then so be it. Well TJ began to attack him for this with a vengeance.

One thing is certain, TJ unjustly treats anyone he comes into close contact with and musters up dissentions. He turns mole hills into mountains and even sees sins where there is no sin, and holds grudges. He is a spoiled brat and a tyrant and bully in the true sense of the word. I do not believe he ever had a true friend in his life.

I knew TJ was on social welfare and played poker to supplement his income, which would be OK if he had worked for the Catholic Church as I wanted him to do; such as, by editing my videos and lectures, making videos and lectures, evangelizing and teaching others. But he only did these things on his time and insufficiently. He spent most of his time playing poker. For example, about 2 months ago I gave him three audios to edit and make a commentary on. After about one month, they were still not done. I forgot I gave them to him. When I remembered, I asked him, What is taking so long? You have all day as you do not have a job. He said he forgot and would get right on it. And he did. He completed one of them or maybe two. But the second one he forgot to add a commentary. He said he forgot, and thus did it. But he did not do the third one. So after about two weeks, I asked him about the third one, and he said he forgot and would get right on it. He does this time and time again.

Also, his income was barely enough to live in a low rent house. I told him that he should then get a job in which he can make enough money as his social welfare and poker was not making him enough money. I did not tell him he had to but only gave him counsel. So he said he would try to find a job, but never found one. He did this several times in the past. He says he is going to get a job but never does. So it seems there are no jobs for TJ in all of Ireland.

TJ Says that No One Can Argue with Me and that I Can Never Admit when I am Wrong

You may hear TJ use out of context words a brother said about me; that is, "Br. Richard is always right, do not argue with him." He should not have said I am always right. But what he meant was do not argue with me with an anger or ferocity that does not warrant the conversion. Then I will have to respond in like and shut it down if it gets too out of hand. TJ wants you do believe that I

can never admit when I am wrong, and that I never allow opposing opinions from mine to be expressed. That is a blatant lie!

Firstly, anyone who knows me or my works knows that am not always right. I admit when I am wrong regarding small matters, medium matters, and big matters (such as heresy). Many times I have publicly admitted I held heretical position and have corrected myself. For example, this is from my article *On RJMI Works*.

Heresies I abjured from

In July 2013, I abjured from heresies I held. (See Abjuration Forms: "RJMI's Abjuration of July 2013.") I have removed my works in which I denied basic dogmas. But if I have missed some, let me know so that I can remove and correct them. However, I have not yet removed or corrected all my works in which I denied deeper dogmas. I am in the process of doing that.

Also, I will uphold an allowable opinion until I come to believe it is wrong. Until then, I will argue the point but not hold it against others who present opposing allowable opinions. That is the normal give and take between men who hold opposing opinions regarding things that have not been infallibly defined by the Catholic Church, or proved in some other way, or made manifest as time goes on. For example, when I debated Gerry Matatics regarding baptism of desire and blood, I believed that the opinion that baptism by water (the reception of the sacrament of baptism) is necessary for salvation was a dogma. Gerry, at that time, believed it was only an allowable opinion and believed in baptism of desire and blood for catechumens. When I studied it more, I realized that my position is not a dogma but an allowable opinion, which I still hold.² Here is what I publicly said in my following book:

RJMI, *Against Gerry Matatics*, 10-2002: "When I debated Gerry I believed it was heresy to teach baptism of explicit desire [for catechumens 3/15/2005], and Gerry proved to me in the debate that it could not be heresy. In this Gerry was right and I was wrong. Gerry believed catechisms are infallible and I said they are not, and in this he was wrong and I was right." (Page 5)

I always said that a man who cannot admit when he is wrong, when he knows he is wrong, can never ultimately be right and will fall into one error and falsehood after another. In short he is a pathological liar.

So what are the reasons one would say "Br. Richard is always right and thus do not argue with him," pretending that I never admit when I am wrong or I do not allow debate regarding allowable opinions. There are two reasons:

- I rightly admonished him of a sin he is guilty of, and he does not want to acknowledge or confess his sin and amend his life. So he puts the blame on me and accuses me of sin for making a false judgment. "A sinful man will flee reproof, and will find an excuse according to his will." (Eccus. 32:21)
- He does not like it when anyone opposes his opinions, not only when one tells him what he must believe (such as dogmas) but even in giving him counsel which he take or leave. "The prudent man doth all things with counsel; but he that is a fool, layeth open his folly." (Prv. 13:16)

In short, no one must tell him he is wrong or may be wrong. And hence it is actually he who can never be wrong or rarely admits when he is wrong. And when he does, many times it is insincere, and he holds a grudge. So the very thing that he falsely accuses me of is the very thing he is guilty of. This also is a part of the heresies of Non-Judgmentalism and Non-Punishmentalism.

Some Proof of TJ's Effeminacy

Here are a few many examples of TJ's sin of effeminacy, mushiness, which makes him suspect of the heresies of Non-Judgmentalism and Non-Punishmentalism. He has had trouble in the past accepting the dogmas on capital and corporal punishment and slavery. I believe he still does, as his effeminacy, comments, and actions indicate. He would be more at home with Mr. Roger's and Bozo the Clown than with manly Catholics.

TJ's email to Mr. X (2/8/2025): It makes sense to me why so many who agree with Richard never join. Its plain as day really, my brother John was shocked at how people acted online. Yet I tried to be fair to him, it is important to be firm with your subordinates, but he is right, Richard goes way too far, way over the top, and just not Christ like, and on many things... I am worried about Phill the most, he is not well (he only tells certain people) and I know he is too loyal to disobey Richard sinful commands. I believe he has put up with many years of, frankly, bullying, and is numb to it all - but you can tell there is a good heart there. So much damage, but I know Gods will be done.

Br. Matheus do Carmo: "2) Not long ago he came up with another one along the lines of "I disagree with br. Richard blunt approach to witnessing", also including br. Ryan."

And he told Br Bruno that he was too hard on his mother when teaching her and trying to convert her.

One wonders why TJ was online and in communion with us barbarians for so long. Would that not mean he committed sins of omission in the very least and also sins of association by remaining in communion with us for so long!

Obviously, he does not read with a good heart the prophets, how good kings treated obstinate evildoers, how St. John the Baptist railed against obstinate evildoers, how Jesus Christ rebuked and treated the evil Pharisees, the Book of the Apocalypse, and how the Church Fathers and popes spoke about and treated obstinate heretics and schismatics.³ What a wimp-shit he is. He is still a peacenik hippie at heart.

And as with all effeminates, when they finally get real, real, real, angry with someone, watch out! The peacenik leaves and the madman enters. They attack in a vicious, irrational rant, rave, and rage, like tyrants. The way TJ attacked me. Like a sissy. They call it a hissy-fit or a sissy-fit.

I end this section with this quote. Now TJ, you may want to look away as this may upset you and cause you to have nightmares and lose sleep or get PTSD.

"And I will give unto my two witnesses, and they shall prophesy a thousand two hundred sixty days, clothed in sackcloth. These are the two olive trees, and the two candlesticks, that stand before the Lord of the earth. And if any man will hurt them, fire shall come out of their mouths, and shall devour their enemies. And if any man will hurt them, in this manner must he be slain. These have power to shut heaven, that it rain not in the days of their prophecy: and they have power over waters to turn them into blood, and to strike the earth with all plagues as often as they will." (Apoc. 11:3-6)

A Warning if TJ Goes Public

As you have just read above, you may very well be the first one this happens to if you make war against me, as you said you would, by publically attacking me and the good Catholics who are with me. And if God does not kill you, he will surely severely punish you:

"It is a just thing with God to repay tribulation to them that trouble you:" (2 Thes. 1:6)

And if you do go public, I expect an exasperating mountain of evidence full of lies, half-truths, out-of-context statements, and testimonies from other disgruntled persons who left the Catholic Church or were kicked out. Do not expect me to waste my time by responding. What I have said in this condemnation of you is enough for good willed men to know the truth, especially those who know you and were in your company for any length of time.


Testimonies from Some Brothers

(Hellenization of Christianity, page 230.).

TJ is highly suspect of holding this heresy.

The Fall of TJ: From Pride to Epicureanism

This is the case of TJ, who, through pride, self-reliance, and an immoderate love of worldly pleasures, has abandoned the truth and embraced the life of an Epicurean.

His Rejection of the Three Pillars

He has rejected sufficient penance, and this is also Epicurean. He avoids sufficient forms of self-denial, refuses to do sufficient penance, and indulges in idleness. Penance is necessary to purify the soul, yet he has no real desire to mortify himself or conform his life to the Gospel.

His Trust in Himself Rather Than in God

He believes evangelization is a matter of technique, boasting, "Oh, let me tell you about my STRATEGY... I might even write a paper about how to talk with elderly people, bla, bla, bla..." Instead of acknowledging that conversion is the work of grace, he sees it as an intellectual challenge—a problem to be solved with clever tactics. This is the sin of pride—placing trust in one's own abilities rather than in God.

His Descent into Epicureanism

What began as self-reliance has now fully devolved into indulgence. Having rejected the supernatural order, TJ now lives according to his passions:

- He plays poker through most of the night, wasting his time in meaningless distractions instead of seeking God.
- He is dominated by pride, arrogance, and self-centeredness, making himself the center of his world.
- He refuses to follow any rules or structure, rejecting the authority of the Church and preferring a life without accountability.
- He systematically avoids getting a job, likely because he believes nothing is worth his time and effort—after all, the bastard sees himself as the "leader" of the Catholic Church!

This is the heart of Epicureanism—living for pleasure, rejecting discipline, and placing all value in worldly comfort rather than in the three pillars, in other words: an effeminate.

We protest, proclaim, exhort, and affirm once more: God, give us the grace to kill and die for the leader You have sent us, Richard Joseph Michael Ibranyi!

One example of recent selfishness is: you took over the house project which I started without prior discussion and, Matheus' invite to live in Ireland and conversation was had without me being informed. Here is what Br. Declan also said about TJ:

"Another example of TJ's behaviour recently was when we were living together. I had asked TJ to implement some rules in the house. One of the rules I asked was to use the living area, which is the sitting room/ television area, to be used as a community room for when people wanted to watch television or socialize. And I asked that we use our bedrooms as our workspace's for anything that we had to do

with MLR online or studying. And I said this will bring order and it would allow the sitting room to be for social occasions only. TJ agreed that it was a good idea but he challenged me on every point and gave an excuse on everything so that he could continue to work on the laptop in the sitting room for his poker and MLR work... He had no intention of going upstairs and working in his room; in fact he found it almost insulting that I asked. Mentally disordered behaviour. He went to bed between 2 and 4am and woke between 11 and 12pm."

Br Matheus do Carmo

Here is an example of Br. Matheus admonishing TJ the day after I admonished TJ on 2/2/2025. So here we have a brother bringing up TJ's sins. And in his email to Mr. X on 2/8/205, he pretends no one ever admonished him for these sins.

You will see how TJ was trying to turn Br. Matheus against Br. Matthew, as TJ thought Matthew's "flip flop" was a sin. And he tried to get Br. Matheus to believe that. As I have said in my letter. It was not a sin. He is entitled to flip flop. In fact, I told Br. Matthew that if he wants to stay in England in between his trips to the US that is fine. In fact, I saved that audio and sent it to TJ to try and get TJ to back off on Matthew. One reason I said this also is because I know TJ is hard if not impossible to live with. I did not tell this to Br. Matthew, but I knew this was a main and justified concern of Br. Matthew, as well as Br. Declan.

This was written before Br. Matheus knew about TJ email to Mr. X in which he placed himself outside the Catholic Church.

Br Matheus, to TJ Delaney, 2-3-2025: "In the name of the Father, and of the Son, and of the Holy Spirit. Amen!

'Brethren, if one of you be overtaken in any fault, you who are spiritual instruct such a one in the spirit of meekness, considering thyself lest thou also be tempted. Bear ye one another's burdens and so you shall fulfil the law of Christ.' (Galatians 6:1-2)

"Brother, you own me nothing, except staying in line, which I also own to you, so I will speak for your good.

"First of all, an apology is necessary in public, but, of course according to repentance. If you write a beautiful 100 pages apology, it won't mean anything for us and for God to forgive you if it was not sincere. SO you can't keep hammering that you apologized, pray that God gives you sincere repentance.

"Second, it's obvious that if you keep pulling towards your side and interpretation, God won't be with you, and you will leave us, and switch to the road of damnation. This can be avoided by prayer, study, and penance, if you're lacking in one of these, or doing them insufficiently (i.e without devotion and discipline) the 3 Pillars will not keep you, even if you don't miss it a day. Therefore, you must recognize your bad standing on this. Forget about what those as saying to you, you're gaslighting. God has revealed it would be impossible to live with you. The housing issue was nothing but an instrument used by God to reveal your heart. Either everyone is wrong and only you are right, or everyone is right and only you are wrong.

"Anyways, upon your request:

"1) I didn't see br. Richard addressing it as mortal sin. But saying you were disrespectful is a slight understatement, you sounded and acted contemptuous and disdainful. When he did a statement about you, you strongly resisted him in a

mortally sinful way. He is our spiritual father, thus you sin against the 5th commandment by such action:

- 'Let every soul be subject to higher powers; for there is no power but from God, and those that are, are ordained of God. Therefore he that resisteth [to stand against] the power resisteth the ordinance of God. And they that resist purchase to themselves damnation.' (Rom 13:1-2).
- "2) Your sins are multiplied if you try gaslighting us, and seek for excuses and multiply your words, this adds to you sin against br. Richard, and fraternal charity:
- 'And be ye, my beloved brethren, every one of you, swift to hear and slow to speak and slow to wrath.' (Jam 1:19)
- 'Speak not any thing rashly, and let not thy heart be hasty to utter a word before God. For God is in heaven and thou upon earth, therefore let thy words be few.' (Ecles 5:1)
- 'He that hideth his sins shall not prosper, but he that shall confess and forsake them shall obtain mercy.' (Prov 28:13)
- "3) You committed a sin of not supporting other brothers' burdens, that is, if they were burdening you, but since you burdened yourself and then, it applies to you as you didn't follow it.


7/29/2024 (a message to a brother concerning TJ, about six months before the Major Incident.)

In essence, from being with him, he's not the most scheduled and organized. He goes to bed late and doesn't have a job to keep routine. I remember on our last evening in Vienna, we wasted so much time finding a spot for him to go swimming, that by the time we got back near the hotel, all of the restaurants had stopped serving food, so we could not have a final meal together. My chief concern is that if I were to live with him, which is looking likely, his routine is out of whack for the average person.
